On behalf of the Oklahoma Hereford Association we would like to invite you to be part of the Oklahoma Hereford Association Annual Fall Bull & Female Sale. The sale date is **Monday, November 16, 2020** and will be at Brooks sale facility in Marietta, OK. Enclosed you will find an entry form please fill out and return with your nomination fee by **Friday, September 11, 2020**. Listed below is the schedule for cattle to arrive.

## **Saturday, November 14, 2020**

9 a.m. - Start receiving cattle at Brooks sale facility in Marietta, OK.

## **Sunday, November 15, 2020**

12:00 Noon – All cattle need to in place at Brooks sale facility by this time.

## **Monday, November 16, 2020**

9 a.m. – Sale cattle on display at Brooks sale facility.

11 a.m. – Lunch – Brooks sale facility.

Noon – Oklahoma Hereford Association Annual Bull & Female Sale.

Matt Sims, Matt C. Sims Auction, Inc. & Dustin Layton, Layton Auction Service LLC. will represent the association as the sale managers and auctioneers. It is our goal to continue to improve one of the nation's best state association sponsored sales by assembling a very high-quality consignment that represents Oklahoma Herefords. The consignments can consist of bulls, cow-calf pairs, bred heifers, bred cows, open heifers, embryos, pregnancies, or a flush. All bulls selling will be required to have both a **BSE exam** and a **Trich test**. The bulls must be 30 months of age or younger to qualify for the sale. **ALL SALE CATTLE MUST BE REGISTERED AND HAVE EPD'S by nomination due date excluding fall 2020 born calves.** Groups of commercial females are eligible for consignment as well. **The sale expense on commercial females will be 6%.**

Matt and Dustin will be inspecting the sale cattle as soon as we start receiving entries. Nominations need to be returned to Layton Auction Service by **Friday, September 11, 2020**. Matt and I will coordinate picture dates once nomination forms are submitted and we can determine where the cattle are located to be pictured. All bulls, cows and bred heifers should be clipped or torched. Calves and open heifers should be clipped in an appropriate manner. If you need assistance please let us know.

Photos will be taken at the time of inspection provided the cattle are ready to picture and a suitable facility is available. Quality, age, pedigree, and body condition will determine eligibility for consignment. A body condition score of six or better should to be maintained until the time of sale. The sale committee reserves the right to screen consignments based on this criteria up to sale day. The deadline for sale cattle entries is **Friday, September 11, 2020**. Everyone is welcome to participate as long as you are a member in good standing of the Oklahoma Hereford Association at the time of the event. Karen Stotz, OHA Financial Secretary can accept dues on the day of The Oklahoma Hereford Fall Sale.

Sale Expense will be calculated on a pro-rated basis of the fixed costs plus 6%, not to exceed a total of 16%. **A non-refundable \$50.00 per lot nomination fee is required on the registered cattle at the time of entry. Please make the check payable to Layton Auction Services, LLC.** and return along with your entries to the address below.
